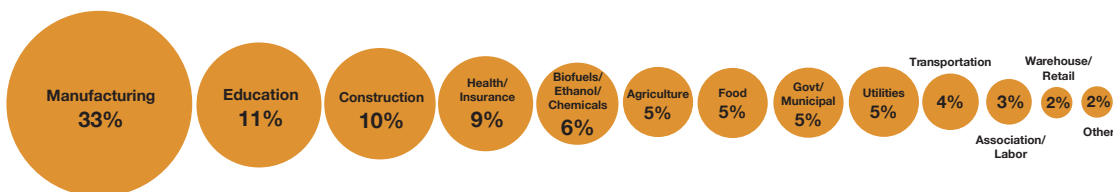

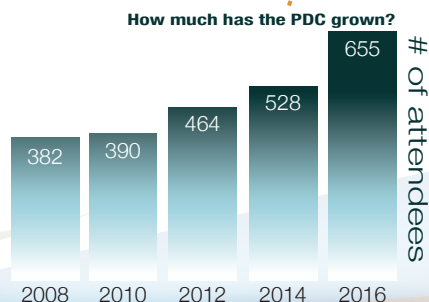

ATTENDEE DEMOGRAPHICS

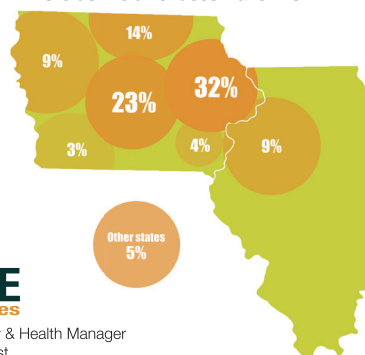

NFPA 70E - ELECTRICAL SAFETY RELATED WORK PRACTICES

This four hour class will cover electrical safety principles as detailed in the NFPA 70E – 2018 “Standard for Electrical Safety in the Workplace”. NFPA 70E now places more emphasis on elimination of electrical hazards through the use of risk assessments and implementation of risk control methods. General Session: “The New Normal: Leadership and Preparedness in the 21st Century”



LT. GENERAL RUSSEL L. HONORÉ (RET.)

Commander of Joint Task Force Katrina & Global Preparedness Authority

Gen. Honoré will share leadership lessons as well as the benefits of developing a culture of preparedness. The “Category V General” discusses the essential qualities that 21st century leaders need, including “decision superiority,” the ability to “see first, understand first, and act first.” On preparedness, Gen. Honoré believes waiting until disaster hits and then responding is dealing with problems on the “right side” of disaster, and that we should be dealing with the “left side” of disaster — before it strikes. Bold and insightful, Honoré’s strategies for making

the world a better place to live are sure to motivate audiences to see local, national, and international leadership issues in a new light.

An American hero who helped a city recover from catastrophe, he shares his bold leadership approach with organizations to help them prepare for the challenges of tomorrow.

Lt. General Russel L. Honoré helps organizations develop a culture of preparedness and problem solving with strategies for transforming individuals into take-charge leaders. As the commander of Joint Task Force Katrina, he became known as the “Category 5 General” for his striking leadership style in coordinating military relief efforts in post-hurricane New Orleans. A decorated 37-year army veteran and global authority on leadership and emergency preparedness, Gen. Honoré now shares his no-nonsense approach to getting the job done by showing organizations how to successfully lead and execute a mission.

Drawing on his in-the-trenches experience managing conflicts of both the natural and man-made variety, his disciplined leadership takeaways inspire audiences in a range of fields, including business, management, government, military and education. Authentic, uplifting and never “stuck on stupid,” Gen. Honoré delivers a bracing dose of candor with real-world leadership lessons that will equip audiences with a mindset of global preparedness and instill confidence in tomorrow’s leaders.

Instead, focus on sound management principles that have been used for years to create and sustain business success and learn how to apply them towards safety management.

NFPA 704 provides a simple, readily recognized, easily understood system for identifying the specific hazards of a material and the severity of the hazard that would occur during an emergency response. The system addresses the health, flammability, instability, and special hazards presented from short-term, acute exposures that could occur as a result of a fire, spill, or similar emergency. This session will take a closer look at the requirements and provide a better understanding of how to interpret the hazards that may occur during emergency operations.

There is PPE available for women in construction and manufacturing, but it is often a challenge to search for it. 
