ABOUT THE IOWA-ILLINOIS SAFETY COUNCIL

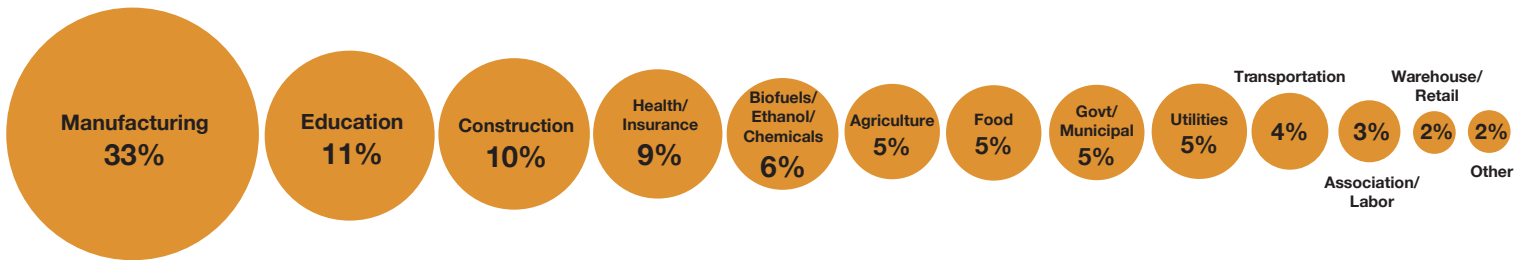

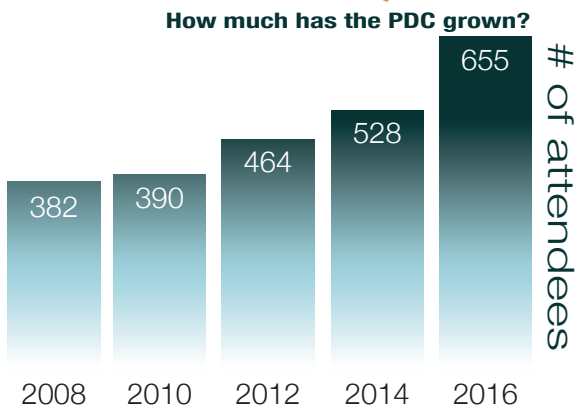

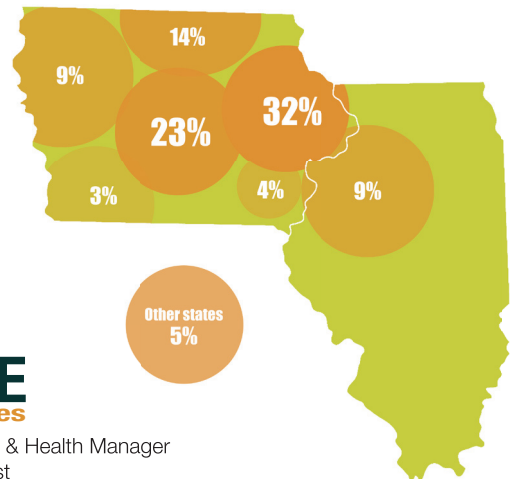
