BILL TOMS

The Safety Pirate

“7,200 Volts Later: The Shortcut That Changed Everything”

Bill delivers a powerful, firsthand account of surviving a life-altering high-voltage incident that changed his future forever. He takes audiences on a compelling journey—from the accident and recovery to rebuilding his life and launching a career in occupational safety. Attendees will gain eye-opening insights into current fatality and injury trends, learn how to use OSHA data to predict risks within their own industries, and understand the most common reasons workplace injuries occur. Most importantly, Bill translates hard lessons into practical strategies, showing how stronger safety management programs can prevent injuries and save lives.



Bill is living proof that one moment can change everything. He survived a 7,200-volt electrocution—an accident that should have ended his story, but instead, it transformed his life. Today, he's taken that life-altering experience and turned it into a powerful mission: to raise awareness, inspire change, and help others prioritize safety in every task. As a safety professional and keynote speaker, he now shares his journey at conferences, workplaces, and events across the country, showing the real consequences of shortcuts and the true value of safety.

Bill began his working career in 1984 by serving four years in the US Air Force, where he first trained to become a power lineman. After leaving the Air Force in 1988, he went to work for MB Haynes Corporation in his hometown of Asheville, NC, where he has worked for 37 years. In 1997, Bill sustained a high-voltage electrical contact incident, which resulted in the amputation of his right hand and foot.

After recovering from his electrocution, he began working in the Safety Department of his company. He is now the VP of Safety and Risk Management for MB Haynes Corporation and is responsible for overseeing the safety of their 650 employees, who work in ten different divisions and perform nearly every trade in the construction industry. Bill is a Certified Safety Professional through the Board of Certified Safety Professionals and a Certified Utility Safety Professional through the Utility Safety & Operations Leadership Network. He has a Bachelor's Degree in Occupational Safety & Health from Columbia Southern University in Orange Beach, Alabama, and is a member of the American Society of Safety Professionals. He is passionate about safety and enjoys talking with others about the importance of working safely and avoiding injuries.

“Lead Like a Hero: Why the Small Moments Matter Most”

In high-risk environments, leadership is rarely defined by a single crisis—it's shaped by the everyday moments that build trust, confidence, and readiness long before something goes wrong.

In *Lead Like a Hero*, Rich Webb draws on nearly two decades of law-enforcement and safety leadership experience to explore the difference between leading with presence and purpose versus leading through avoidance and fear. Through powerful stories and practical insights, this keynote focuses on the 99.9% of leadership moments that determine how teams perform, communicate, and follow when it matters most.

Attendees will gain a deeper understanding of how intuition, preparation, and difficult conversations play a critical role in safety culture—and why relationships, not titles, are the foundation of effective leadership.

Rich Webb is the co-founder of Blue Ethos Specialized Training and brings 18 years of frontline law-enforcement experience into his work today.

Throughout his career, Rich served in high-responsibility roles including patrol sergeant, mobile field force leader, and hostage negotiator—roles that demanded calm communication, decisive leadership, and sound judgment under extreme pressure.

In 2014, Rich was awarded the Minnesota Chiefs of Police Medal of Honor for his actions during a life-threatening incident on the steps of a daycare—an experience that helped shape his commitment to preparation, teamwork, and leadership when it matters most.

In 2020, Rich led his department Mobile Field Force team during the Minneapolis civil unrest, operating in an environment defined by uncertainty, high emotion, and rapidly evolving threats. That experience further reinforced the importance of disciplined decision-making, trust, and leadership under sustained pressure.

Now retired from law enforcement, Rich works full-time with Blue Ethos Specialized Training, where he has trained organizations across the United States. His work focuses on strengthening active threat preparedness, situational awareness, improving communication under stress, and building safer, more resilient teams.

1A: Using FMEA to Reduce Safety Risks

Carl Vass - Falcon Safety

I should have seen that coming. Risk and hazards can often be predicted and eliminated by the use of Failure Mode and Effects Analysis (FMEA) when we know how to use the FMEA technique to mitigate risks and track progress.

1B: Beyond Pounds: The Hidden Truths Behind Toxic Release Inventory (TRI) Data

Most TRI discussions focus on pounds released, recycled, or treated, but behind every number lie assumptions and human decisions that influence public-facing numbers. This session helps participants identify common reporting errors and apply practical QA/QC methods to improve data accuracy and consistency.

1D: Proposed Changes to NFPA 70E - 2027

NFPA 70E - 2027 is set to be released later in 2026. Many changes including, additional persons, contact thermal hazard, and a complete rebuild of Chapter 3 (batteries risk assessment and solar installations). See how the new revisions affect your existing electrical safety and maintenance programs.

In 2017 OSHA initiated the Walking Working Surfaces Standard for General Industry. 3A: Elephants in the Room: Unspoken Factors that Impact Safety Conversations

George Gruetzmacher - WI State Laboratory of Hygiene - UW Madison
"They just don't get it?" Have you that conversation where someone doesn't get that there is a serious hazard and they need to wear their PPE? Or maybe someone has this concern about a hazard and you just know that the risk is really small. Often there is a disconnect between your approach to safety and theirs. Often the issue is not the underlying risk, but a difference in one of these unspoken factors: one of the elephants in the room.

3B: Safety that Pays: Turning Wearable Leading Indicator Data and Predictive Analytics into Measurable Business Value

3D: NFPA 70e the 101's and Updates

We will discuss the 2024 updated standard and what changes were put in. We will discuss the OSHA announcement in Nov 2024 and how that impacts the employer along with the basics on the standard around training, hazard risk assessments, PPE requirements and understanding on labels along with a checklist of what they are missing currently today in their program.

3E: Export Manifests & e-Manifests: What Shippers and Generators Must Do in 2026

Andrew Ewald - Trinity Consultants

This presentation will explain the federal requirement for hazardous-waste export manifests to be submitted to EPA's e-Manifest system beginning December 1, 2025, and outline what this means for generators, transporters, and brokers operating in 2026. Attendees will learn how the expanded e-Manifest framework changes documentation, recordkeeping, and communication obligations for waste export shipments under RCRA. The session will cover applicability, roles and responsibilities, data elements required for compliant submission, timing requirements, and common errors that create enforcement risk. Practical guidance will be provided for updating internal SOPs, onboarding staff and vendors to the e-Manifest system, verifying data quality, and building an internal compliance checklist to ensure seamless transition ahead of the 2026 operating year.

4A: The Hidden Factor in Building a Culture of Safety

Karen Schumacher - Crescendo Leadership Development

Behind every checklist and protocol is a powerful driver of safety outcomes: the Emotional Critical Path. While organizations often focus on technical controls, up to 70% of incidents are driven by human and behavioral factors. This engaging, story-driven workshop helps safety leaders understand and manage the emotional forces that shape focus, trust, and decision-making, using emotional intelligence tools to strengthen communication, engagement, and safe work practices.

4B: Beyond the Hard Hat: How Virtual Reality and AI Are Rebuilding the Way We Train

Edward G. Weiss - EG Weiss & Associates

Virtual reality is changing how we teach safety, compliance, and operations. E.G. Weiss explores the science behind immersive learning, the proven gains in retention, and the real-world savings in time and cost. Blending humor with hard data, he shows how VR and AI are transforming onboarding and maintenance training while reframing fears of "robot takeover" into opportunities for innovation, reassignment, and human-centered efficiency.

4C: Teaching the Skill of Working Safely - Equipping Your Workforce with Mental PPE

Richard Flynt - National Safety Council

As a consultant for the NSC, one of the most common questions I hear from clients is, "How can we get our employees to work more safely?" While we don't blame workers for making errors and we know we cannot eliminate human error, we absolutely can and should work to reduce it wherever we can. When asked what "working safely" means, most will say something like "Wearing your PPE and following the safety rules". Well, that is only the starting line for developing the true skill of working safely! If we expect our people to work safely, it's only fair that we teach them HOW! That is what this presentation is about. Along the way, we'll have some fun, and demonstrate an approach to presenting safety concepts in a way that "locks them in" to your employees' memories so they are not easily forgotten.

4D: Every Breath You Take - A Review of Toxic Gases

Dr. Pamela Moore & Dr. Rebecca Kusko - University of Iowa Health Care

This presentation will provide a brief overview of toxic gases focusing on routes of exposure and early management. We will discuss two mass casualty events, two high-risk gases related to farming, and common household exposures.
